AFFIDAVIT OF PROBABLE CAUSE

Your Affiant is Detective Sergeant Matthew R. Lawhead of the Richland Township Police Department. Your Affiant has been a sworn Police Officer for Richland Township since 2002. He has completed criminal investigative training conducted by the U. S. Federal Bureau of Investigation and the Bucks County District Attorney's Office.

The facts set forth in this affidavit are based upon Your Affiant's personal knowledge; knowledge obtained from other individuals/entities during my participation in this investigation, including other law enforcement personnel; review of documents, video surveillance footage and records related to this investigation; communications with others who have personal knowledge of the events and circumstances described herein; as well as information gained through your Affiant's training and experience.

On June 18, 2025, Your Affiant received a CY47 from Bucks County Children and Youth, alleging an adult male shop keeper at the QUAKERTOWN FARMER'S MARKET, had made offers to female employee, who was a minor, to provide money and drugs in exchange for sexual acts.

On June 23, 2025, Your Affiant had the opportunity to interview the victim, D.S. 17 yr old female, and her mother. Through the course of the interview the victim advised that she used to work at POPPY'S PEANUTS, a store within the QUAKERTOWN FARMER'S MARKET. She advised that he boss, a Joseph GROSSMAN, would make frequent inappropriate comments, and made a habit of touching her legs and back, which led her to resign from the position.

Following her resignation, GROSSMAN would continue to contact her by SnapChat. On June 8, 2025, she advised that she was contacted by GROSSMAN, who stated that he wanted to see her puppy. She advised that she stopped at the business, which was after business hours. On scene, he asked "How long until you turn 18?", to which she replied that she didn't turn 18 until February of next year. He then offered her marijuana and \$100 if she would let him "TittyBump" her. She advised that she became very defensive, and said that she was not a prostitute. She advised that he then offered her \$300 and pulled a roll of cash from his pocket. She advised that she then left the store.

Your Affiant then proceeded to POPPY'S PEANUTS, and made contact with Mr GROSSMAN. On scene, Your Affiant advised him of the allegation, and he responded "Get the fuck out of my store, you can talk to my lawyer."

Wherefore, Your Affiant respectfully requests that a warrant be issued for Joseph GROSSMAN, so that he can answer to the charged listed in this complaint.
