

Inside the envelope was a letter on Bucks County Office of Jury Selection Commission letterhead, which included the names of the Bucks County Court of Common Pleas President Judge Wallace H. Bateman, Bucks County Court Administrator Stephen Heckman and Bucks County Office of Jury Selection Commissioner Patricia Kloenne. The letter read:

**Affidavit of Probable Cause**

The letter was signed in black ink. The envelope was sent via United States Post Office Certified Mail (tracking number 7015 1730 0002 1258 8206). This letter originated in Doylestown, PA (Bucks County) on July 15, 2019 and was delivered on July 19, 2019. The letter cost \$6.85 to send.

Melissa Silva advised your Affiant that she had hired Steve Wolfe to perform a home improvement project at her residence. This project, for which she received a bill via email from Steve Wolfe ([wolfe2080@gmail.com](mailto:wolfe2080@gmail.com)) on June 12, 2019, included the pressure washing of her siding and other cosmetic repairs/painting. The total of this bill was \$674.75, which included \$157.50 for the pressure washing.

Silva was unhappy with the quality of the pressure washing Wolfe had performed, claiming there were dirty spots all over the house after he had finished. Silva issued Wolfe a check on June 20, 2019 in the amount of \$517.25, which was the amount of Wolfe's bill minus the estimate for the pressure washing. This check was endorsed by Wolfe and subsequently processed through the Lehigh Valley Educators Credit Union on July 8, 2019.

On June 26, 2019, Silva's mother, who provided house cleaning services for Wolfe, received an email from Wolfe via [wolfe2080@gmail.com](mailto:wolfe2080@gmail.com). Wolfe indicated he was very unhappy with Melissa having "*shortchanged*" him for the pressure washing.

On July 18, 2019, Silva's mother received an email from Wolfe via [wolfe2080@gmail.com](mailto:wolfe2080@gmail.com) which read:

*“Not good! I sent a certified letter to your daughter requesting that she pay me the balance of what she owes me or I will go to my lawyer. If she doesn't pay me by the end of this month, she will be hearing from my attorney. If she wants to spend a lot of money on lawyers, so it will be. This has become personal. She ripped me off.”*

In a follow up email to Silva's mother also on July 18, 2019, Wolfe continued to complain about the lack of payment. In this email, Wolfe cc'ed the email address lynnowens57@gmail.com. The name next to the email address was Lynn Owens.

Silva further advised your Affiant that on July 19, 2019, after receiving the letter, she called the Bucks County Office of Jury Selection Commission at the telephone number which was listed on the letterhead of the document. Silva advised that the female who answered the phone identified herself as Lynn. Silva advised Lynn that she had received a letter from Steve Wolfe. Lynn responded, *“I believe Steve sent you a letter.”* Silva said that she did not understand the letter, to which the female replied, *“Maybe you should read the letter.”* When Silva questioned why the letter was coming from the Bucks County Office of Jury Selection Commission, Lynn responded, *“That's all. Bye bye,”* and terminated the call.

On August 2, 2019, Silva, her four (4) children and her mother drove to the Bucks County Criminal Justice Center to inquire further about the letter. After speaking with representative of the Bucks County Clerk of Courts, Silva filed a complaint with the Bucks County District Attorney's Office.

Owens worked in the Bucks County Office of Jury Selection Commission as an assistant/clerk to Patricia Kloenne. Your Affiant requested, and obtained, a copy of Lynn Owens' Bucks County email backup file. I was provided this file from a representative of the Bucks County Information Technology department. Your Affiant reviewed the Outlook files and located an email from Lynn Owens ([lrowens@buckscounty.org](mailto:lrowens@buckscounty.org)) to Steve Wolfe ([wolfe2080@gmail.com](mailto:wolfe2080@gmail.com)) on July 12, 2019 at 9:46am. The email, titled "Rough Draft", was found in the sent emails folder. The email read,

*"Hi Love,*

*Shall I finalize and print?*

*I Love you Steve!!!*

*Lynn R Owens*

*Assistant Jury Clerk  
Bucks County Justice Center  
100 N Main Street  
Doylestown, PA 18901-3711"*

The email also contained an attachment, which consisted of a Microsoft Word document titled "wolfe 2080.docx." Your Affiant was able to open the attachment and found that "wolfe 2080.docx" was the document sent to Melissa Silva on July 15, 2019. The Bucks County Office of Jury Selection Commission letterhead was at the top of the document.

On August 2, 2019, your Affiant received additional information from a representative of the Bucks County Information Technology Department. The Bucks County IT representative located a file called "wolfe 2080.docx" saved locally on a computer at the location c:\Users\lrowens\Documents. It was last saved at July 12, 2019 at 9:45am by the

user "Owens, Lynn R." The computer showed that it was last signed into by Lynn Owens and is assigned to her in the Bucks County Inventory tracking software.

On August 5, 2019, Bucks County Detective David Coyne and your Affiant interviewed Lynn Owens. Owens admitted to creating the letter on her work computer and emailing same to Steve Wolfe. Owens further advised that Steve Wolfe signed the document, which was placed in a Bucks County Office of Jury Selection Commission envelope, which she then sent to Silva via certified mail through the United States Postal Service. Owens was aware that she used Bucks County Office of Jury Selection Commission letterhead, which contained the names of Judge Bateman, Heckman and Kloenne, as Wolfe had asked her to draft a letter which appeared official in order to "prompt" Silva to pay the \$157.50 to Wolfe.

On August 5, 2019, Bucks County Detectives John Slattery and Timothy Campbell interview Steve Wolfe. Wolfe admitted to signing the letter Owens created, which contained the letterhead of the Bucks County Office of Jury Selection Commission and the names of Judge Bateman, Heckman and Kloenne. Wolfe advised Detectives Slattery and Campbell that he told Owens what to put in the letter and was trying to "send a message" to Silva. Wolfe further acknowledged sending emails to Silva's mother regarding the certified letter he had sent.

Judge Bateman and Stephen Heckman were each in excess of sixty (60) years of age at the time of the creation and receipt of the letter Owens and Wolfe sent to Silva. Neither Judge Bateman, Stephen Heckman nor Patricia Kloenne authorized the use of their respective identifying information for the purposes of the creation and distribution of the

letter Owens and Wolfe sent to Silva in an effort to obtain \$157.50 from Silva for perceived unpaid services.

Wherefore, your Affiant submits that there is probable cause to issue an arrest warrant for Lynn Robin Owens for the violations of the following sections of the Pennsylvania Crimes Code: §7611 Unlawful Use of Computer and Other Computer Crimes, §903 Criminal Conspiracy, §4120 Identity Theft, §4101 Forgery, §5301 Official Oppression and §901 Criminal Attempt – Theft by Extortion (§3923).
