OVERVIEW OF POLICE ACTIVITY

THE POLICE DEPARTMENT RESPONDED TO **20,876** CALLS IN 2025. OF THESE, **10,451** CALLS IN EAST LAMPETER AND **2,823** CALLS IN UPPER LEACOCK REQUIRED A WRITTEN REPORT. AMONG THOSE, **3,593** EAST LAMPETER CALLS AND **972** UPPER LEACOCK CALLS WERE INITIATED BY OFFICERS.

THE POLICE DEPARTMENT MADE A TOTAL OF **677** ARRESTS FOR **CRIMINAL CODE VIOLATIONS** IN 2025. THE DEPARTMENT ISSUED A TOTAL OF **2,470** CITATIONS TO MOTORISTS FOR **VEHICLE CODE VIOLATIONS** AND ARRESTED **104** DRIVERS FOR **DRIVING UNDER THE INFLUENCE OF ALCOHOL OR A CONTROLLED SUBSTANCE**.

THERE WERE **1135 VEHICLE CRASHES INVESTIGATED**, OF WHICH **908** WERE IN EAST LAMPETER TOWNSHIP AND **227** IN UPPER LEACOCK TOWNSHIP. **371** WERE *PENNDOT* REPORTABLE CRASHES. THERE WERE **4** FATAL CRASHES IN EAST LAMPETER TOWNSHIP AND **0** FATAL CRASHES IN UPPER LEACOCK TOWNSHIP.

THE POLICE RESPONDED TO A TOTAL OF **866 BURGLARY/ROBBERY/PANIC FALSE ALARMS** DURING THE YEAR. THAT NUMBER IS **UP** FROM THE 2024 TOTAL OF **814** FALSE ALARMS.

THERE WERE **SIX (6)** INCIDENTS INVOLVING **THIRTEEN (13)** JUVENILES DURING 2025 FOR CURFEW ORDINANCE VIOLATIONS IN EAST LAMPETER TOWNSHIP. THE CURFEW INCIDENT COUNT IS UP **TWO (2)** INCIDENTS IN 2024

THE POLICE DEPARTMENT HAS RECEIVED NO CITIZEN COMPLAINTS REGARDING THE ENFORCEMENT OF THE ORDINANCE. WE HAVE ALSO NOT EXPERIENCED ANY DIFFICULTY ENFORCING THE CURFEW ORDINANCE AND HAVE SEEN NO EVIDENCE TO INDICATE THE ORDINANCE CAUSES ANY NEGATIVE IMPACT ON THE COMMUNITY.

RECOMMENDATION:

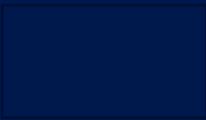

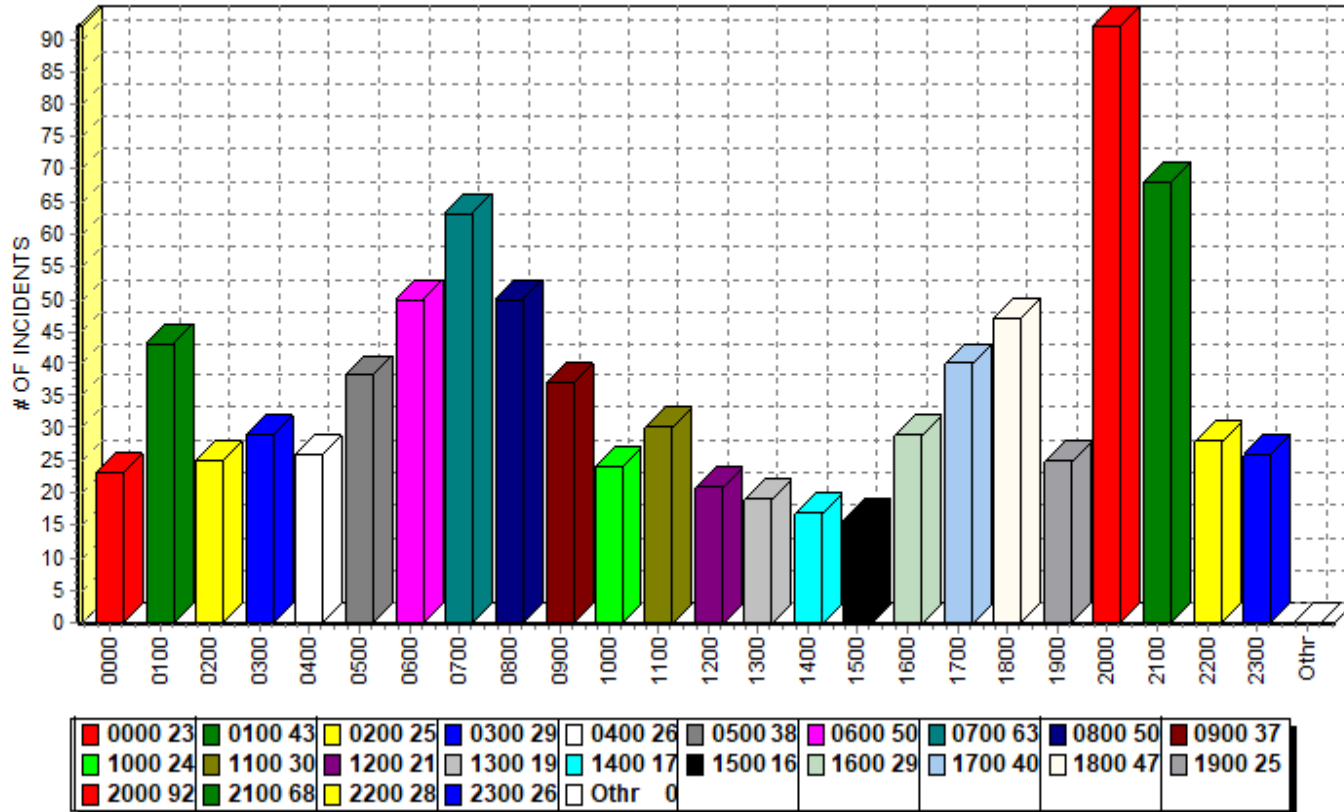

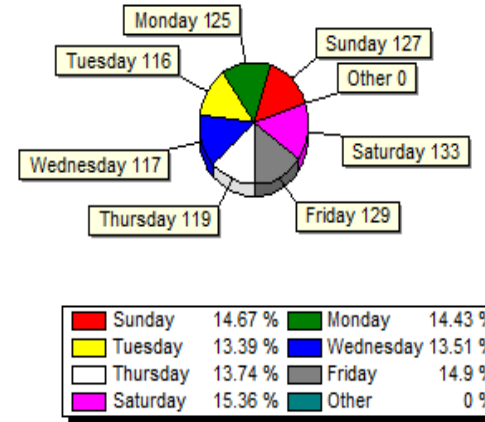


TOTAL FALSE ALARMS 2025

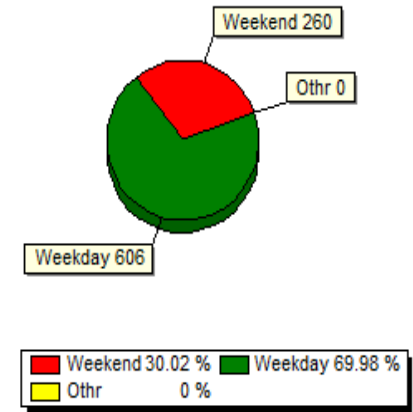
Incident Frequency by Hour of the Day (Using DATE RECD)

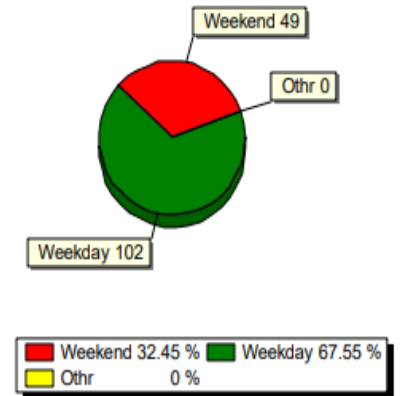
Incident Frequency by Hour of the Day (Using DATE RECD)

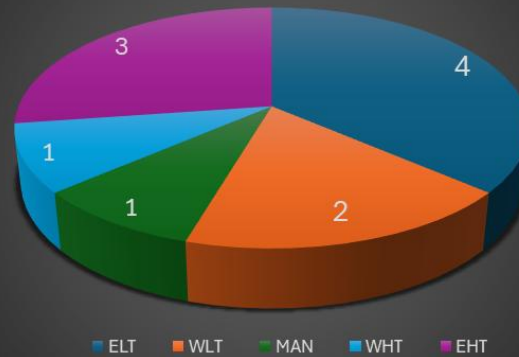

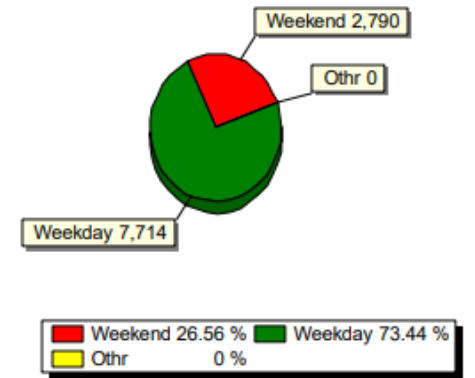
Incident Frequency by Month (Using DATE RECD)

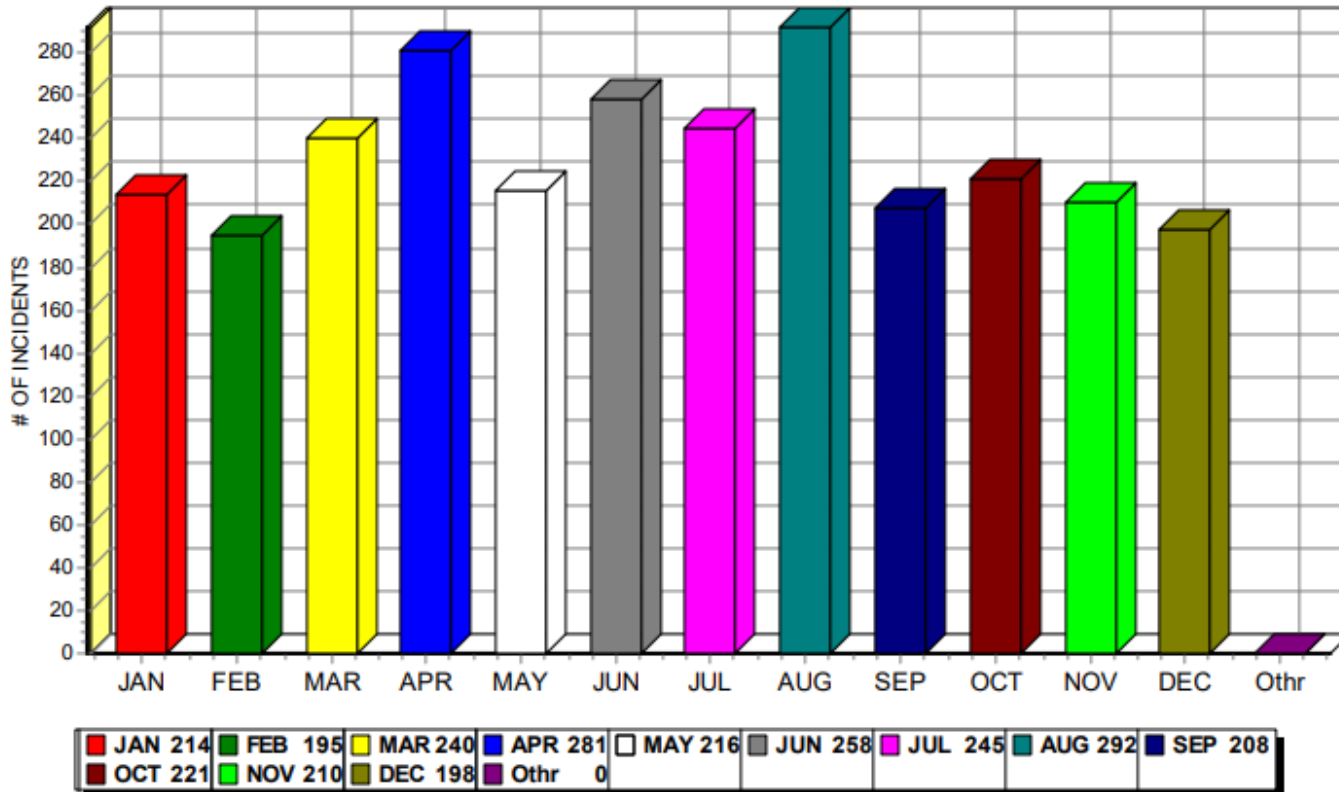

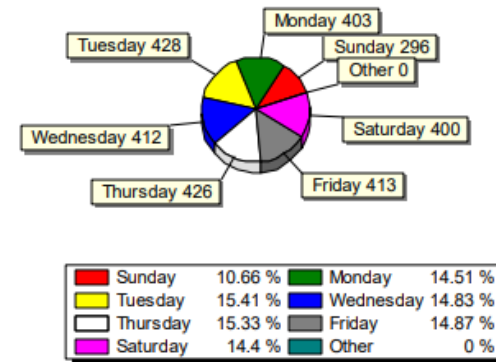

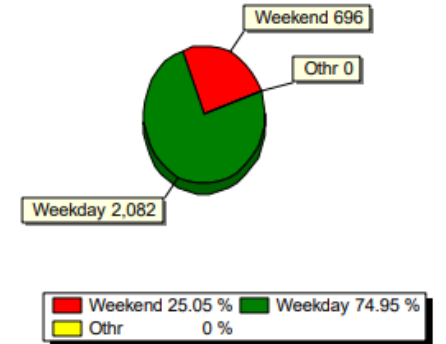
Incident Frequency by Month (Using DATE RECD)

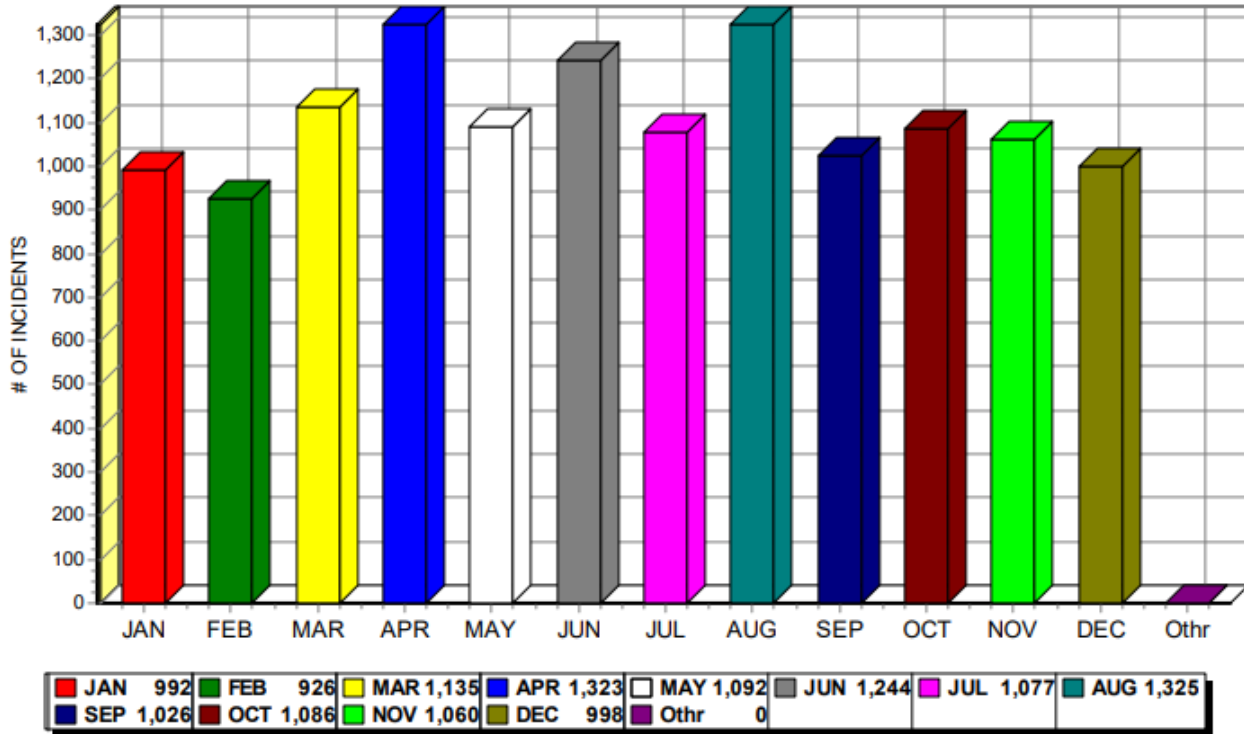

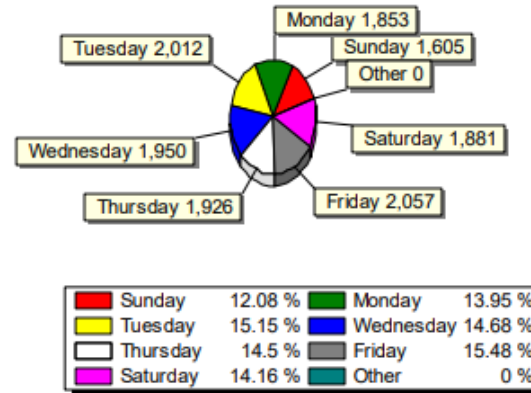


TOTAL INCIDENTS BY MONTH 2025

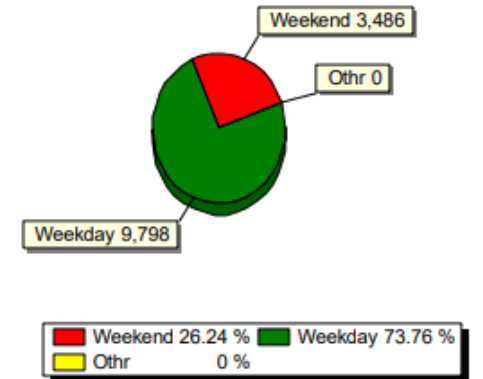

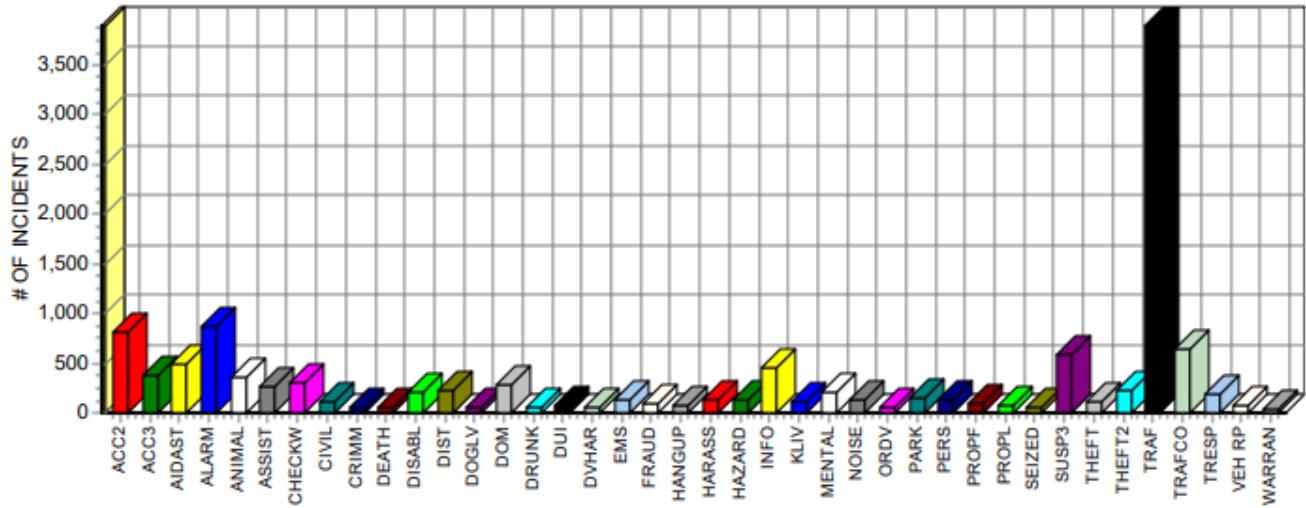

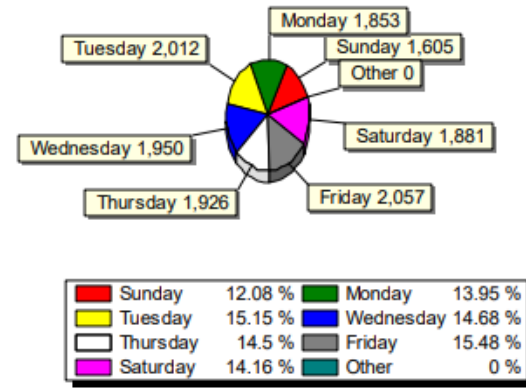
TOTAL INCIDENTS BY TYPE 2025

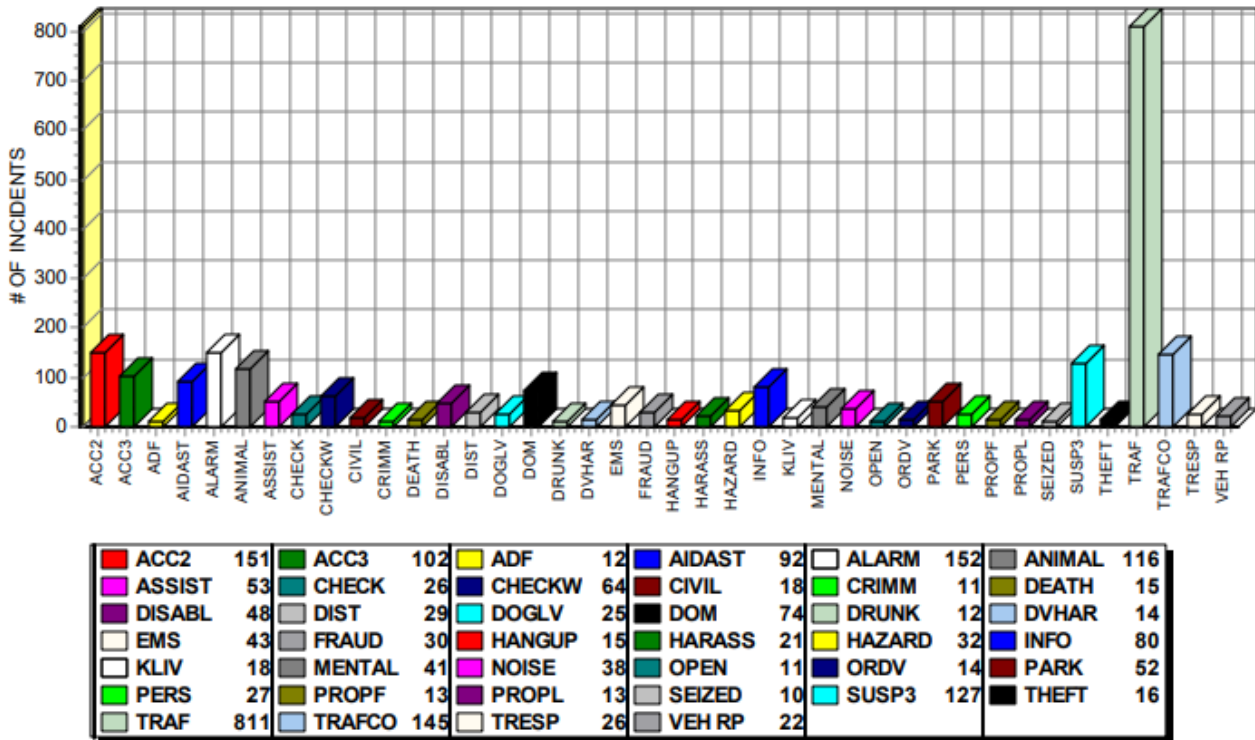

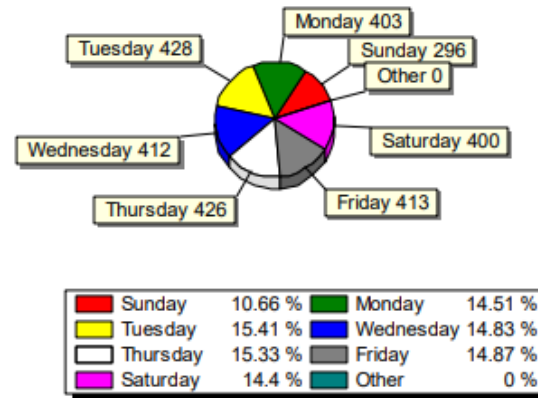


UPPER LEACOCK INCIDENTS BY TYPE 2025

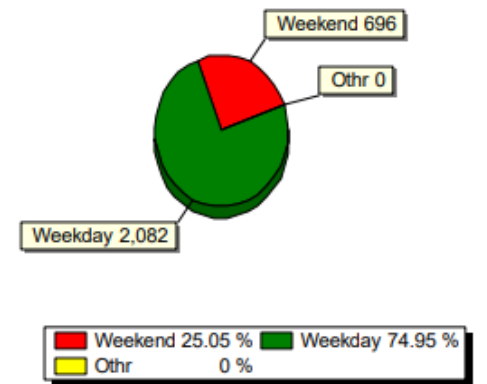
